OUR OBJECTIVES

To promote the welfare of older people living in the London Borough of Croydon in any manner which now is or hereafter may be deemed by law to be charitable.

GRANT APPLICATION PROCESS:

Applications are invited for grants that meet our Objectives to help improve the welfare of elderly people living in the London Borough of Croydon.

Applications are considered by our Board of Directors in March and September each year. Applications must be received prior to these meetings. Organisations can apply for a grant once in any year. In exceptional circumstances the Board may consider an additional application for a specific urgent need. The Board will review and assess the merits of which applications to support. Applicants will be informed of the decision following the review and assessment.

Applications are to be submitted using the attached form together with a letter on your organisation's headed paper.

Each application must include the following minimum information. Failure to include the required information may result in the application not being considered

- A concise overview of the key aims of your organisation.
- An idea of the numbers of people who have benefitted from your service over the last 3 months.
- A clear statement of how much money is being applied for and specific information about what it will be used for.
- Details of any other funding you may receive this year.
- If you wish to purchase an item or to have work carried out you need to include copies of the supplier's quotes on the expected costs. Copy invoices are to be sent on completion.
- A copy of your most recent audited accounts. If you have large reserves shown in your accounts, explain why.
- The address to which our decision letter should be posted.
- If the application is successful, the name to whom cheques should be made payable.
- If possible include some recent news about your organisation.
- If applicable refer to previous successes that you have had showing how your work will make a difference and how you will measure this.
- Applications may be sent by email attaching the required forms and all supplementary information.
- If you are submitting your application by post, you should send 4 copies of all the paperwork to us.

For your information:

- Grants are usually in the range of £250.00 to £1,000.00. but may vary in exceptional circumstances. These should be clearly defined within your application.
- In the event of an unsuccessful application organisations are invited to reapply for the next round of funding.
